



## Report on the results of the agreed-upon procedure

Asian Taekwondo Union

January 23, 2024

We have performed the agreed-upon procedure with Asian Taekwondo Union (collectively referred to as the "ATU") as follows, in relation to the Continental Union Development Fund expenditure details for 2023. The procedure we performed was carried out to help evaluate the legitimacy of the expenditure details of the Continental Union Development Fund supported by the World Taekwondo.

The agreed-upon procedure we have performed to carry out to help evaluate the legitimacy of the Continental Union Development Fund expenditure is as follows:

- 1. We received the Continental Union Development Fund expenditure details for 2023 and balance as of December 31, 2023, from ATU, and verified that the balance matches the balance in the bank account.
- 2. We have verified the expenditure documents for the entire expenditure details of the Continental Union Development Fund for 2023.

As a result of performing the agreed-upon procedure, our findings are as follows:

- 1. The balance of the Continental Union Development Fund matches the balance in bank account as of December 31, 2023.
- 2. We have verified the expenditure documents for the entire expenditure details of the Continental Union Development Fund for 2023, No exceptions were found for the occurrence of expenditure details.



The above procedures do not audit in accordance with accounting audit standards or review in accordance with review standards for financial statements. Therefore, we do not provide any assurances regarding the Continental Union Development Fund expenditure details.

Other findings to report to ATU may be discovered if we perform additional procedures other than agreed-upon procedure or if we perform an audit in accordance with the accounting audit standards or a review in accordance with review standards for financial statements.

This report is to be used only for the purposes mentioned in the first paragraph and for informational purposes of ATU and may not be distributed to third parties except World Taekwondo or used for any other purpose. In addition, this report relates only to the expenditure and balance mentioned above and cannot be extended to the financial statements of ATU.
